

Retirement Expense Worksheet

Estimate the expenses you have *before* retirement and those you will have *during* retirement (if you are *currently* retired, estimate your current expenses only). Keep in mind that during retirement, some of your expenses may decrease (i.e. dry cleaning) or expire (i.e. you paid off your home mortgage); while other expenses may increase (i.e. more traveling).
